If you have to choose between time and money, what would you choose? Though it's not uncommon to hear people say that they don't have time but mostly the choices that we make every day are guided more by the fact – how much money it saves instead of time. We forget that each day, at dawn, our daily account of life is credited with 86400 seconds and as the day finishes the value of this asset TIME is reduced to zero. So apart from being an arbitrary number which is based on the Earth's rotation and revolution, it is also a valuable resource with certain peculiar characteristics - only you can consume this asset and no one else; you can never regain time that is once spent. Besides all the other valuables in this world – family, heath, material possessions, etc, TIME is the most precious asset.

Results of a study "Buying Time Promotes Happiness" highlights that if money is spent on time saving purchases then it results in greater satisfaction and happiness. They explored "time scarcity" as a new form of poverty.

And finally, as it's rightly said by Harvey MacKay "Time is free, but it's priceless. You can't own it, but you can use it. You can't keep it, but you can spend it. Once you've lost it you can never get it back."

So I believe it is TIME to understand TIME and use your TIME - effectively and efficiently





Does an entrepreneur really need formal management education?

Entrepreneurship is not just limited to starting one's own business. An entrepreneur is a person who identifies opportunities, allocates resources and creates value. An entrepreneur is a person who jumps off the cliff and builds a plane on the way down. In order to find out whether formal management education is necessary in order to be a successful entrepreneur or not, let us first examine what are determinants of entrepreneurship.

Availability of finance is the first and the foremost determinant of entrepreneurship. An entrepreneur needs to carefully manage his funds in order to obtain the goals and objectives of his start-up effectively and efficiently. Patience and entrepreneurship are inseparable twins. Being an entrepreneur is indeed very challenging and requires a lot of patience, consistency and determination. The early profits might not be sufficient enough to fully recover the cost. An entrepreneur before launching his product in the market needs to check and ensure whether his product will be accepted in the market or not. He also needs to find out the degree of competition in the market and whether there is fair competition in the market or not. For example, Maruti Udyog became the leader of small car market because it was the first to identify opportunity of selling small cars in an environment of increasing petroleum prices and very large middle-class population.

Furthermore, a successful entrepreneur identifies threats and early warning signals easily. Threats refer to the changes in the business environment that adversely affects the performance of the business. For example, if a company in its domestic market finds out that a new multinational enterprise is entering in the market then they would have to take it as an early warning signal and look for a remedial solution to this threat. The domestic company can improve the quality of their product or could invest more in the advertising of the product to bring it to the knowledge of the prospective buyers.

Entrepreneurship and management are distinct. While in entrepreneurship the focus is on a business start-up whereas in being a manager the focus in on an ongoing operation. While a managers approach to the business is mostly formal. An entrepreneur has a more informal approach towards the business. So does a person who adopts an informal style of management needs formal management education?

Determination, tenacity and the ability to take certain risk is something that formal management education cannot teach you. The time and expenses involved in management education can also can as a drawback of FME(formal management education) for entrepreneurs. It is also said that entrepreneurs have a continuous appetite for risk but students who are in debts might find theirs completely diminished. Some people also argue that competition moves really fast especially in the tech industry. If the product or the service of an entrepreneur is fully developed and he has good source of funding combined with a determined team then he is said to be all set to launch his business plan. Additionally, it is said that everyone has their own life journey. What might be suitable for a certain category of people might not be suitable for another category of people. Just because few entrepreneur have been successful after pursing formal management education we cannot say that other category of people will be successful too. For example a person with a great business idea finds that he is completely out of funding after completing his FME. In a survey conducted by Harvard Business School, some respondents think that it is a good idea to pursue FME for as it teaches entrepreneurs important things like how to read and interpret financial statements while others argue that an entrepreneur read those statements only to figure out that he is completely out of cash!

FME is required for aspiring entrepreneurs as it provides a great network to students. The professors in the college can act as a constant guide and support for entrepreneurs. In order to pursue formal management education in countries of North America, a student needs to have a minimum of 2-3 years of work experience. An entrepreneur pursuing FME in these countries will interact with experienced people who can act as a guide for them. In addition, the brand of the business school can be helpful to attract investors. For example, a graduate of London School of Economics might not find it difficult to attract investors. Also, an entrepreneur's character gets developed while pursuing FME as it offers the best environment to build team and network.

A business school will teach you how to grow and run your company and not just launch it. Also, it is argued that if an entrepreneur chooses a business school that relies heavily on case methods then they will likely learn from the mistakes and success of others. A lot of business schools in the world emphasize on learning by the method of case studies. This indeed can a lot helpful for students, especially for the aspiring entrepreneurs. For example, a student while reading different business plans might discover a similar business plan that he has in his mind. The student can learn about the advantages and the challenges that he might face in putting his business plan into action. FME also teaches an entrepreneur diverse subjects. It not only teaches them how to read and analyze financial statements but also teaches them the art of human resource management. HRM is a set of policies, practices and programs that are designed specifically in order to obtain personal and organizational goals. It is a binding force between people and organization so that the objectives of each are achieved. It is also said that entrepreneurship is never a solo sport. It involves working with diverse minds in order to achieve the goals and objectives. Therefore it is essential to know the art of managing a diverse crowd.

Not only this, FME teaches you how to meet impossible deadlines. These deadlines mimic what actually might happen in the real world. FME gives an entrepreneur the security of a stable career. For example, an entrepreneur might find out that he is completely out of finances after pursuing his management education. In an adverse situation like this, his management education can promise him a stable career. Let us now imagine that an entrepreneur did not go for formal management education and had launched his enterprise after trusting his business idea. In the time of adversity, he will have nothing to his rescue. With these ideas, one can definitely say that formal management education is necessary for entrepreneurs.

UNION BUDGET 2018

The Union Finance Minister Arun Jaitley announced various schemes in the Union Budget 2018-2019 on Feb 1, 2018. These Budget schemes have been announced with the objective to uplift the poor and farmers.

The Union budget 2018-2019 is the Modi government's last full year Budget in which the Finance Minister began his speech by highlighting the government's economic reforms undertaken in the last four years and its achievements.

Here, we will see all the new schemes launched by the government in the budget 2018-2019.

1) Kifayati Aawas Yojna: The central government will create a dedicated affordable housing fund in national housing bank. In the budget 2018-2019, Jaitely said that "My Government will set up a dedicated affordable housing fund in the national housing bank, which will be refunded from the loans given to priority sector". The Government has planned that by the end of 2022, everyone will have their own house. For this, more than one crore households are being constructed in the rural areas in the current and next financial year under the Pradhanmantri Aawas Yojna.

2) Ayushmaan Bharat Scheme (National Health Protection Scheme): National Health Protection Scheme will be launched to cover 10 crore poor and vulnerable families. Under this, up to Rs.5 lakh will be provided to each family per year in secondary and tertiary care institutions. The scheme will have 50 core beneficiaries .So far under the National Health Insurance Scheme, insurance cover of Rs.30000 was available only. This is a big increase in this regard.

3) Kisan credit card to fishermen: On the lines of kisan credit card, the finance minister has announced a card to fisherman and cattle owners. This will make enable them to avail the easier loans. The government says that this will help the people associated with the milk production business in rural areas. Apart from this, financial assistance will also be provided to fisheries.

4)Gobar-Dhan Yojna (Galvanizing organic Bio-Agro resource fund scheme): The government announced a new scheme Gobar-Dhan (Galvanizing organic Bio-Agro resource fund) scheme under its efforts to improve the lives of the villagers .The government said that under this scheme, solid waste of dung and fields will be changed into compost and biogas and bio CNG . He said that under the vision of inclusive society formation, the government has identified 115 districts for development.

5) National Bamboo Mission: Finance minister Arun Jaitely has also proposed the proposal of National Bamboo Mission. An amount of Rs.1290 crore will be allocated under this scheme. This will help in the development of bamboo production as an industry .This will help the people of rural and tribal areas.

6) Eklavya School: As per the finance minister, the Eklavya schools will be established for scheduled caste students by 2022 along the lines of Navodaya schools .He said that Eklavya model residential schools will be set up in each block having more than 50% tribal areas and 20000 tribal people. These schools will be a part of navodaya vidyalayas and besides training in sports and skill development, there will also be special facilities for preserving local art and culture.

7) Revitalizing Infrastructure and Systems in Education (RISE): In his budget 2018 speech, Jaitely unveiled a new scheme called Revitalizing Infrastructure and Systems in Education or RISE. The RISE scheme will be financed via a restructured higher education financing agency (HEFA) that is functioning for last two months as a non-banking financial company. It aims to lend low-cost funds to government higher educational institutions. Presently, HEFA is looking to raise Rs.20000 crore and budget announcement hiked this number to Rs. 1 trillion. While HEFA was granted a budgetary allocation of Rs. 250 crore in the fiscal year 2018 ,FY19 , the lending body will be provided a budget of Rs. 2750 crore .

8) Operation Green: The goal of the scheme is to double the farmer's income by end of the year 2022. With the budget allocation of Rs.500cr, finance minister Arun Jaitely has announced about the Operation Green in union budget 2018. This scheme will facilitate the farmers of the nation. This will be in line with the operation flood. To reduce the fluctuation in the pricing of onion, tomatoes and potatoes the scheme has been launched.

9) Prime Minister fellowship scheme: Finance Minister Arun Jaitely also announced the PM Fellowship scheme during the budget. Under this, one thousand B.TECH students will be given the opportunity to do Ph.D. in IIT and IISc.

10) Expansion of Ujjwala Scheme: Modi Government has set a target to provide the number of free LPG connections to the poor families under the Ujjwala scheme to reach 8 crores.
11) Saubhagya Yojna : The government has targeted to increase the number of power connections in rural areas to 40 million households .this scheme is one of PM modi's ambitious plan .

IS INDIA FACING A MIDDLE INCOME TRAP?

Middle income trap is a situation when country's growth slows after reaching middle income levels. The transition to high income levels then seemingly becomes unattainable. This is often attributed to disappearance of factors that generated high growths in the initial phase of economic development. This is a phenomenon that has been witnessed in India and many other countries of the world.India is classified as a lower middleincome country (per capita GDP between \$1,026 and \$4,035). It achieved that status in 2007 and is likely to remain a middle-income country for many more years. Brazil, Mexico and South Africa have remained middleincome countries for over 25 years now. Russia has yo-yoed in and out of middle income over the last 10 years. Countries are often "trapped" because of excessive dependence on a resource economy (Brazil, South Africa, Russia) or inadequate innovation, reform and competitiveness (Mexico).

However the recent economic survey has negated the phenomenon and has found out that the economic 'convergence' between poorer countries that were "catching-up" with more developed economies has broadened and even accelerated since the mid-1980s. Between 1960 and 1980, only 43.7 per cent of countries grew faster than the US (the "frontier economy") and they outpaced the US by 1.4 per cent. Between 1980 and 2017, those numbers grew to 68.6 per cent, which outperformed the US by 1.7 per cent. But the recent global developments have led to a late convergence stall in the development process and it is especially true for India.

Currently India faces a challenge from countries such as Vietnam, Bangladesh, Thailand, Congo where cheaper labour is available and also from global innovators such as US, Japan, Germany. This pressure coupled with factors such as low R&D expenditure (mere 0.6% of GDP), impeded

structural reforms, hyper globalization repudiation , Human capital regression induced by technological changes and agriculture distress faced by India makes it a really challenging task to improve its growth and jump to upper middle income slab.

Given the low odds, escaping the trap requires meticulous long-range thinking and we would do well to begin now. As a late 'converger', India faces considerably stronger growth headwinds than many other countries however It's never too late to do the right things. But if we don't do them, there's apocalypse ahead.

PEOPLE'S BUDGET

Budget is telling your money where to go instead of wondering where it went. We all know the importance of budgeting household expenses where one has to be aware of the income and adjust expenditure accordingly. We are also aware of the well-known saying "aamdani athani, karchha rupaiya" (income eight annas and expenditure one rupee). A household where there is no grip on expenditure, link to income goes haywire. Having a budget means you make a plan and don't let budget go out of control.

A nation's budget is not any less crucial to the well-being of its citizens. Assessing income from various heads and adjusting expenditure accordingly is what the wise administrators of the nation do. Just like the household budget, there are allocations for education, health contingencies, upkeep of basic infrastructure, etc. in the nation's budget too. The Union Budget 2018-19 is the last full budget of the current government before the general elections. The government has tried to balance its allocations so as to plan programmes and allocate funds in critical areas like agriculture, rural development, infrastructure and health.

In a nation where agriculture is still the main stay for the population, farmers' welfare has to be high on the agenda of any government. The government, in it's budgetary allocation for agriculture, has put it's weight behind agrarian reforms. A clear set of initiatives which mark a paradigm shift in agricultural allocations include Operation Green to address price fluctuations in tomato, onion, potato, increase in MSP of kharif crops by one and half time, upgradation of 22,000 rural haats into Gramin Agricultural Markets (GrAMs), agri credit to farmers, etc.

Rural development, an allied area to farmers' welfare has also been accorded place of pride in the budget with focus on building rural infrastructure and creating employment opportunities. To fulfil the target of Housing for All by 2022 more than one crore houses are proposed to be build by 2019 in rural areas, besides additional 2 crore toilets to be build under Swachh Bharat Mission. Higher targets for women self help groups, Saubhagya are likely to cater to concerns of lower and middle class. Double allocation for food processing industries as against last year to Rs. 1400 crore, setting up of funds for fisheries and animal husbandry and restructuring of National Bamboo Mission are part of the government's emphasis on improving farmers' income and create opportunities of entrepreneurship in the rural allied sector.

Health care has received substantial in the budget. Being acclaimed as world's largest health care protection scheme, the National Health Protection Scheme (NHPS) places health care in the centre stage with the provision for cover of upto 5 Lakhs rupees per year to over 10 crore poor and vulnerable families while the Ayushman Bharat Programme provides for a corpus of Rs. 1,200 crore to set-up 1.5 Lakh Health and Wellness Centres.

On Education front, announcement of setting up of Ekalavya Model Residential School to provide quality education to the tribal children in their own environment is a welcome step. A New Scheme – Prime Minister's Research Fellows (PMRF) would facilitate 1,000 best B.Tech students to do Ph.D in IITs and IISc, with a handsome fellowship.

With a view to providing a dignified life to senior citizens the budget has announced slew of measures like exemption limit of interest income on deposits with banks and post offices being increased from Rs. 10,000 to Rs. 50,000 and raise in the limit of deduction for Health Insurance Premium and Medical Expenditure from Rs. 30,000 to Rs. 50,000. The Pradhan Mantri Vaya Vandana Yojna providing for an assured return of 8 per cent on investment of upto Rs. 15 Lakh as against previously Rs. 7.5 lakh has been extended upto March 2020.

Describing the MSMEs as the engines of growth the budget has focused on the micro, small and medium enterprises with an allocation of Rs. 3794 crore for the purpose of credit support, capital and interest subsidy and innovations. This will in turn help in rapid job creation and self employment opportunities for youth.

The Government has taken 'Ease of doing business' further by focusing on ;Ease of Living' for the citizens of the country. All in all this a budget working towards inclusive growth in important sectors of the economy touching on people's lives.






